Following decisions were taken:-

Agenda Item No 1: Decisions on all complete pending cases

The cases on this agenda were discussed and decided online.

During the meeting, the following decisions were also taken in the meeting:-

- (i) In the meeting, all complete pending cases were taken up. The gist of the cases considered today's meeting are as follows :-

- (ii) It was apprised to the committee by worthy chairman that during the meeting unit selects multiple activity (more than one) but only one activity is shown on the consent portal of the application. In this regard, IT Cell is directed to work on the issue so that multiple activities of the unit can be shown on portal.
- (iii) Whereas During the meeting, it was apprised to the Committee by Incharge, CMC-I that in some cases, unit has applied its consent application with minor incorrect information w.r.t. spelling of name/address & selecting the activity etc. and after filing, it has noted and requested to DPCC to correct the same. In this regard, CMC-I is directed to put up a policy note in consultation with IT Cell for framing a uniform policy in such types of cases.
















- (iv) It was observed that after deposition of payment by the unit / applicant, payment receipts have been generated; however, the said amount has not been transferred to DPCC account. Therefore, IT Cell has made a provision to first forward the application(s) required payment will send to Account Section for checking the payment from DPCC account. Considering the same, Chairman of the Committee decided and directed to Account Section do the same on daily basis without fail.
- (v) The Committee has not taken up the cases of those units which were either water polluting or generating hazardous waste operating in industrial / redevelopment areas. The Committee in previous meeting has taken the decision to put up the said issue before II(a) category committee. In recent past, no meeting of II(a) category committee could not be held.
- (vi) The Committee decided to grant **Consent to Operate (Renewal)** to the units those are generating incinerable/recyclable hazardous waste with the condition that unit shall make an agreement with the authorized operators for collecting / disposal of incinerable/recyclable hazardous waste. Subsequently, inspection be conducted. Authorization under HWM Rules be kept in abeyance in view of directions of CPCB in certain types of wastes generated.
- (vii) During the meeting, it was decided to issue registration under Plastic Waste Management Rules, 2016 after issuance of Consent to Operate/Consent to Operate (Renewal) if the documents are found in order.
- (viii) It was decided to put up only complete cases (including inspection findings wherever is applicable as per orders/policies) before the Committee. If any discrepancies found in consent application, the concerned EEs/AEEs of concerned CMCs shall issue the clarification for submission of requisite documents within 03 days. If unit fails to submit the same, Show Cause Notice shall be issued giving 07 days as a final opportunity. If unit again fails to upload the requisite documents in spite of issuance of clarifications / SCNs, Committee, therefore, decided to refuse all such applications and in case of CTO / CTO (R) and issue Show Cause Notice u/s 33(A) of Water Act and u/s 31(A) of Air Act for operating without consent from DPCC.
- (ix) It was apprised to the Chairman of the Committee that some of the units have applied for Consent to Establish / Consent to Operate / Consent to Operate (Renewal) after imposition of Environmental Compensation (EC). Committee deliberated the issue and it was decided that unit shall deposit Environmental

Compensation (EC) and thereafter Consent to Establish / Consent to Operate / Consent to Operate (Renewal) be issued.













- (x) All CMCs are directed to re-check each and every documents including required consent fee before issuing the Consent to Establish / Consent to Operate/Consent to Operate (Renewal).
- (xi) If any Consent to Establish / Consent to Operate application (s) (for the activity generating hazardous waste / generating trade effluent discharge) in industrial areas has been granted by the Committee inadvertently, the said decision shall be reviewed and the consent application shall be kept in abeyance.

Note:-All CMCs Incharges to ensure that decisions of the Committee are conveyed/consent granted/refused to the unit within 03 days from the date of issuance of this minutes.
