

Following decisions were taken:-

Agenda Item No 1: Decisions on all complete pending cases

The cases on this agenda were discussed and decided:.

During the meeting, the following decisions were also taken in the meeting:-

- (i) In the meeting, all complete pending cases were taken up upto 17.11.2022. The gist of the cases considered today's meeting are as follows :-

- (ii) CAQM issued closure directions for operating without consent(s). Now, the unit, namely, M/s The Cookware Industry, B-71/7, Phase-1, Mayapuri Industrial Area, Delhi-110064 has applied for consent(s) without mandatory test report(s). In such cases, it was decided that Consent to Operate be granted with the condition that unit shall not operate till getting the revocation letter from CAQM and subsequently, after the revocation order, unit will file test report(s) from NABL laboratory /DPCC laboratory meeting the stipulated standards within 30 days thereafter.

- (iii) Member Secretary DPCC deliberated the issue of pending consent applications of units generating hazardous waste or water polluting or both. It was apprised that in-compliance to the direction of the Hon'ble NGT order dated 21.07.2020 and subsequent


advice from advocate the, the Consent Management Committee is keeping in abeyance the applications of CTE and CTO of the units which are generating hazardous waste in anticipation the TSDF facility shall be commissioned soon.

- (iv) DPCC vide HWM authorization letter No. DPCC/WMC-II/Bawana TSDF/2021/9046-9054 dated 04.03.2022 has granted authorization and vide letter No. DPCC/WMC-II/Bawana TSDF/CTO/2021/9037-9045 dated 04.03.2022 has granted Consent to Operate to Tamil Nadu Waste Management Ltd. the operator of TSDF site at sector-5, Bawana for collection, storage, transportation, reception, reuse, recycling, recovery, pre-processing, co-processing, utilization, treatment and disposal of hazardous waste (except incineration) generated and collected from the industries/CETPs/units/establishments/organizations etc. in NCT of Delhi.
- (v) As most of the units have entered into an agreement with TSDF facility operator and DPCC has issued hazardous waste authorization as well as Consent to Operate under Air & Water Act to Tamil Nadu Waste Management Ltd. the operator of TSDF site and the same is operational.

In view of above development following decision has been taken to reduce the pendency of consent applications:-

Concerned CMC to put up a file to seek legal opinion from the advocate associated in the matter OA no. 159/2013 titled as "All India Lokadhikar sangathan vs. NCT of Delhi & others" on following points:-


- a. To allow CMC to decide the grant CTE/CTO and hazardous waste authorization to the units where applications for CTE/CTO of industrial units have been kept in abeyance by Consent Management Committee in want of TSDF Facility in Delhi, which has now been operationalized..
- b. To allow CMC to reject the consent applications of II(a) category units (water polluting) which are pending for more than 120 days (eligible for deemed consent) as per clause no. 25(7) of the Water (Prevention and Control of Pollution) Act, 1974 on account of pending upgradation of CETP in the industrial area where the units are located.
- c. To allow CMC to reject the consent applications of II(a) category units (water polluting) which are pending for less than 120 days on account of pending upgradation of CETP in the industrial area where the units are located.

-  (vi) All CMCs are directed to re-check each and every documents including required consent fee before issuing the Consent to Establish /Consent to Operate/Consent to Operate (Renewal).

- (vii) If any Consent to Establish/ Consent to Operate application (s) (for the activity generating hazardous waste / generating trade effluent discharge) in industrial areas has been granted by the Committee inadvertently, the said decision shall be reviewed and the consent application shall be kept in abeyance.

Note:-All CMCs Incharges to ensure that decisions of the Committee are conveyed/consent granted/refused to the unit within 03 days from the date of issuance of this minutes.

The meeting ended with a vote of thanks to the Chair.
