OFFICE ORDER

In pursuance of the directions from Commission for Air Quality Management of NCR Region and adjoining areas the Chief Secretary, Delhi has taken a meeting on 05.10.2021 wherein it was decided that Construction and demolition activity in NCT of Delhi has to be undertaken only after ensuring the Dust Mitigation Measures as prescribed from time to time.

Hon'ble National Green Tribunal has passed certain directions for controlling environment pollution in Delhi and also fixed compensation to be paid for violation in term of the Section 15 of the National Green Tribunal Act, 2010 for polluting the environment.

In pursuance to NGT orders and decision taken in the meeting of Chief Secretary, Delhi on 05.10.2021, following teams of DPCC have been constituted and are hereby authorized to carry out surprise inspection/special drive wrt dust control measures in the construction activities of plots with built up area above 500 Sq. mtrs and to levy Environmental Compensation on defaulter/ violators and to initiate further action.
