- The wording 'No change or No Addition or As in the previous by every member of Group A & Group B officers under relevant provisions of Conduct Rules and the first appointment to the service and thereafter, at the interval of every twelve months, giving particulars of all immovable property owned, acquired or inherited by him or held by him on lease or mortgage either in his own name or in the name of any member of his family or in the name of any other person dependent on Government Servant.
