NOTE-1. For purpose of Column 8, the term "lease" would mean a lease of immovable property from year to year or for any term exceeding one year or renewable for a further term. 2.- In Column 10 should be shown-

Where it has been acquired by lease, the total annual rent thereon; and

Where the acquisition is by inheritance, gift or exchange, the approximate value of the property so acquired.
