CORRIGENDUM

In partial modification of previous circular no. F.No. 01/PL/Accounts/DPCC/ 2017/ 584-595 dated 12/06/2017, the contents mentioned on the said circular are herein after to be read as under:

1. Aadhaar Card number of the beneficiary shall be optional while applying for subsidy on E-Rickshaw through the concerned MLO.
2. In case of already registered E-Rickshaws, the concerned MLOs may obtain the Aadhaar Card number of beneficiaries (if available) for reimbursement of subsidy for E-Rickshaws.
3. As approved by Hon'ble Chief Minister, Govt. of Delhi, entire work of E-Rickshaw subsidy is to be dealt by Transport Department w.e.f. 08/09/2017.

INSTEAD OF

1. Aadhaar Card number of the beneficiary shall be mandatory while applying for subsidy on E-Rickshaw through the concerned MLO.
2. In case of already registered E-Rickshaws, the concerned MLOs shall obtain the Aadhaar Card number of beneficiaries, as all reimbursement of subsidy for E-Rickshaws will be made only on the production of Aadhaar number through concerned MLO office.
4. Transport Department shall submit a single/comprehensive list to DPCC (after obtaining data from all MLOs) certified by the nodal officer of Transport Department on monthly basis by 20<sup>th</sup> of next month through hard copy & on e-mail ID at [bov.dpcc@gmail.com](mailto:bov.dpcc@gmail.com) for grant of subsidy.
