Sub : Lifting of the ban on the operation of Electricity Generator Set run on Diesel / Petrol / Kerosene of all capacities in NCT of Delhi, imposed vide Directions u/s 31 (A) of Air (Prevention and Control of Pollution) Act, 1981, issued by DPCC on 18.10.2017

Whereas, Directions under section 31(A) of the Air (Prevention and Control of Pollution) Act, 1981, were issued by Delhi Pollution Control Committee on **18.10.2017** banning the operation of Electricity Generator Set run on Diesel / Petrol / Kerosene of all capacities in NCT of Delhi excluding Electricity Generator Sets used for essential services such as Medical Purpose (Hospitals / Nursing Homes/Health Care Facilities) , Elevators (Lifts) / Escalators & Railway Services / Railway Stations / Delhi Metro Rail Corporation services including its Trains & Metro Stations , Airport & Inter State Bus Terminus (ISBTs) with immediate effect and upto **15.03.2018**, as per the decisions taken by the Environment Pollution (Prevention and Control) Authority (EPCA) in its meeting held on **17.10.2017**.

And whereas, Environment Pollution (Prevention and Control) Authority (EPCA) in its meeting held on **28.02.2018** has decided to lift the aforementioned ban on the operation of Electricity Generator Set run on Diesel / Petrol / Kerosene of all capacities in NCT of Delhi with effect from **01.03.2018**.

Now therefore, in view of the above decision taken by EPCA in its meeting held on **28.02.2018**, Delhi Pollution Control Committee hereby lifts the ban on the operation of Electricity Generator Set run on Diesel / Petrol / Kerosene of all capacities in NCT of Delhi, imposed vide said Directions u/s 31 (A) of Air (Prevention and Control of Pollution) Act, 1981, issued on 18.10.2017, with effect from **01.03.2018**.
