Eligibility Criteria/ Technical Bid

Following Essential Documents should be submitted with the technical bid failing which the tender shall be rejected.

1. Earnest Money of Rs. 10,000/- (Ten Thousand only) in form of Demand Draft in favour of **Delhi Pollution Control Committee**.
2. Self Attested copies of Registration Certificate of VAT / TIN Number of Delhi.
3. Self attested Copy of PAN Certificate.

Above said three document shall be kept in a sealed envelope which shall be superscribed as **"Technical Quotations for Sale of 03 (three) old unserviceable / Scrap Govt. Vehicles"**.

Sealed financial quotation comprising price for Sale of 03 (three) old unserviceable / Scrap Govt. Vehicle shall be superscribed as **"Financial Quotations for Sale of 03 (three) old unserviceable / Scrap Govt. Vehicles"**.

Both the envelopes containing Technical Quotation and Financial Quotation shall be put in outer envelope. The outer envelope shall be superscribed as Quotation for **Sale of 03 (three) old unserviceable / Scrap Govt. Vehicles** and should be addressed to Member Secretary, Delhi Pollution Control Committee, 5th Floor, ISBT Building, Kashmere Gate, Delhi-110006 and shall invariably be dropped in the sealed tender box at the enquiry counter, 6th Floor, ISBT Building, Kashmere Gate, Delhi-110006 before or on 30.06.2014 at 01.00 PM.

1. The successful bidder / claimant shall have to give an affidavit before taking delivery of the vehicle(s) that the vehicle(s) will not be used for any private or commercial purpose or made road worthy.
2. No NOC / Registration Certificate (RC) shall be given / issued by the department because the vehicles are being sold as "Scrap".
3. The Chasis Number of the vehicles shall be cut out / removed from the scrap vehicles and retained by the DPCC for physically depositing to Transport Department for De-Registration of the Vehicles against the name of this department as per procedure.
4. Highest bidder will have to submit proof of his / her identity (Voter I-Card / Aadhar Card / Passport or any other authentic proof) to department before taking away the **scrap** vehicles.
5. Highest vendors will be required to deposit entire quoted amount in cash or in form of Demand Draft in favour of Delhi Pollution Control Committee and will take the delivery of the vehicles from the Caretaker, DPCC at his own expenses within three (03) days failing which EMDs may be forfeited without any further notice.
6. Vehicle will be delivered on "As is where is" basis as **scrap**.
7. Interested bidders are advised to check the physical condition of above said **03 (three) old unserviceable / Scrap Govt. Vehicles** between 10.00 AM to 4.00 PM on all working day before submitting the quotations. **Any plea raised by successful bidder about dissatisfaction with regards to physical conditions of 03 (three) old unserviceable / Scrap Govt. Vehicle will not be entertained.**
