ADDENDUM

Sub: Direction under section 31 (A) of Air (Prevention and Control of Pollution) Act 1981 read with Rule 20A(6) of the Air (Prevention and Control of Pollution) (Union Territories) Rules, Act 1983 to stop operation of Electricity Generator set run on diesel/ petrol/ kerosene in Delhi.

1. In continuation of earlier directions issued vide letter No DPCC/ MS/2016/ AP/ 327 to 335 dated 6/11/2016 followed by its addendum vide letter no. DPCC/ MS/2016/ AP/5408-5415 dated 17.11.2016, and considering the high levels of air pollution particularly PM₁₀ & PM_{2.5} levels, operation of Electricity Generator set run on diesel/ petrol/ kerosene of all capacities is further banned in Delhi till **28th February 2017**, barring use for essential services such as medical purpose, elevators (lifts) & escalators. All the Authorities (Govt or private) / person/ Officer in Delhi are hereby directed to stop the use of Electricity Generator set run on diesel/ petrol/ kerosene as indicated above till 28th February 2017. The SDM and officers of Local Bodies shall **comply** with directions as above and submit daily action taken report (ATR) to "DPCC" on Email id **msdpcc@nic.in**.
2. In case of non-compliance, action as per the provisions contained in Section 37 of the Air (Prevention and Control of Pollution) Act 1981 shall be initiated against all defaulters.
