OFFICE ORDER

In continuation to this department's order no. DPCC/BOV/2012/5129-5145 dated 02/09/2015 and in pursuance of approval by Legislative Assembly, Delhi to the proposal at para 60 page 24 of Budget Speech Booklet for the year 2016-2017 i.e. enhancement of one time fixed subsidy for E-Rickshaw from existing subsidy of Rs. 15,000/- to 30,000/- for every E-Rickshaw that has been registered by the Transport Department w.e.f. 01/04/2016. Accordingly the approval of competent authority is conveyed for one time fixed subsidy of Rs. 30,000/- will be given to Battery Operated E-Rickshaw owner, authorized by Transport Department and registered with registering authority of Transport Department.

An individual can claim subsidy on one E-Rickshaw. On subsequent purchase by the same individual, no subsidy will be allowed.

The subsidy will be given by DPCC from Air Ambience Fund.
