Sub: Appointment of Counsels as Retainer/ Empanelment for Supreme Court/ High Court/National Green Tribunal/ District Courts/ Statutory Appellate Authority in the Panel of Delhi Pollution Control Committee.

Delhi Pollution Control Committee proposes to empanel practicing Advocates as Panel counsels and Standing Counsels for Supreme court/High Court/ National Green Tribunal/ District Courts/ Statutory Appellate Authority etc. The eligible and willing advocates having required qualification and experience may apply in the prescribed Performa. The counsels of DPCC may also apply in the prescribed format for fresh empanelment, if they desire.

Qualification and Experience for Retainer/ Empanelment Counsel in Supreme Court:

- (1) Bachelors degree in law from a recognized university and registered with any Bar council of Delhi.
- (2) Having practice as an advocate for not less than 15 years in Supreme Court of India and must be an advocate on record and should have a chamber in Supreme Court.
- (3) Having good communication skills and good knowledge of law and procedure.
- (4) Counsels having advocate experience in handling matters related to environmental laws will be preferred.

Qualification and Experience for Retainer/ Empanelment Counsel in High Court/ National Green Tribunal/ Appellate Authorities:

- (1) Bachelors degree in law from a recognized university and registered with any Bar council of Delhi,
- (2) Having practice as an advocate for not less than 10 years independent experience out of which 5 year in High Court in handling civil and criminal matters in Delhi High Court and should have a chamber in High court
- (3) Having good communication skills and good knowledge of law and procedure.
- (4) Counsels having advocate experience in handling matters related to environmental laws will be preferred.

Qualification and Experience for Retainer/ Empanelment Counsel in District Courts/ National Green Tribunal/ Appellate Authorities:

- (1) Bachelors degree in law from a recognized university and registered with any Bar council of Delhi,
- (2) Having practice as an advocate for not less than 5 years in Delhi District Court either in Civil/ Criminal/ or both and should have a chamber in District court.
- (3) Having good communication skills and good knowledge of law and procedure.

- (4) Counsels having advocate experience in handling matters related to environmental laws will be preferred.

Mode of Selection:

- (1) The mode of selection will be interaction by selection committee.
- (2) The department reserves the right to decide the criteria of short-listing the applications on the basis of number of applications received.
- (3) Candidates so short listed will then be called for interaction intimation will be sent at the correspondence address given in the application form or/and over the telephone number/ e-mail given by the applicant.
- (4) Candidates will have to produce all original documents at the time of interview/ interaction,
- (5) The engagement will be initially for a period of two years which may be extended further subject to the satisfactory performance/ conduct of the counsel.
