Agenda-1.

Review of ATR of the previous meeting held on 11.11.2008

The Committee reviewed the ATR of the decisions of the last meeting. The following are the records of discussion.

- i. EE BMW informed that a note was sent to AO (Admin.) through Member Secretary DPCC for providing copies of bare Act. But no information in this regard has been received. It was decided that the matter shall be perused at the personal level by EE/SEE.
- ii. The case of Dr. Dangs Pvt. Ltd. D-1, Hauz Khas, New Delhi-16, was discussed. It was informed that another letter has been received from the lab, informing that the installed stack with the DG sets has been broken by the occupant of the first floor. The Committee decided that since a case is pending in the Hon'ble High Court of Delhi, the file be put up administratively for deciding the next course of action.
- iii. Regarding the issuing of Authorization letters to 135 units, as decided in the last meeting, it was informed by EE BMW that the letters have not been issued so far. This issue was taken up very seriously. EE BMW was instructed to issue these letters immediately. EE was also advised to implement the decisions of the Committee in a time bound manner. A review in this regard shall be done by SEE BMW on 08.12.2008 at 12.00 pm.

Agenda No.2

Application for grant of Authorization.

The Committee perused 155 applications, seeking Authorization under BMW Rules. It was observed that in many cases, the copy of fresh agreement with the common Bio-Medical waste operator was not available with DPCC. The Committee observed that their applications should not be kept pending on account of this. It was, therefore, decided that the Authorization letters should be issued to those units which have valid agreement. For this purpose, both the operators should be asked to provide an authenticated list of HCUs who have valid agreement with the operators. The decisions taken are available in **Annexure-I**.

The Committee recommended that after issuing the Authorization, a sample survey of 10% of those case where Authorization have been granted, shall be done by the trainee engineer to check the compliance with BMW Rules.

Agenda-3

Inspection report by Trainee Engineer in respect of 40 cases.

It was informed by the Trainee Engineer that except one all the pending inspections have been carried out by him and a detailed report as per **Annexure-II**, indicating the deficiencies has been prepared. The said report was perused by the Committee and it was decided a letter be issued to those units which are not complying with the BMW Rules. These units should be asked to remove the deficiencies and submit a compliance report in the form of an affidavit within one month. Further, those units which have not provided the acoustic enclosure / adequate stack height should be asked to take necessary action within a period of two months and submit a compliance report in the form of an affidavit.
