OFFICE ORDER

In continuation of the decisions taken by Chief Secretary, Govt. of NCT of Delhi, in the meetings held on 08.12.2010, 14.07.2011 and 09.12.2011 regarding closure /shifting of the unauth orized / illegal/ non-conforming industries in non-conforming / residential areas of Delhi, now a Policy Decision has been taken by the Chairman, DPCC and approved by the Chief Secretary, Govt. of NCT of Delhi that Delhi Pollution Control Committee shall take action against the polluting Industries operating in non conforming/residential areas of Delhi as well. Hence forth it will also take cognizance of complaints received by it against following categories of industries / units operating in non conforming / residential areas of Delhi:

1. 'H' Category units as per Master Plan of Delhi 2001.

2. 27 'F' Category units as identified by an Expert Group(of Nodal Agency of MOUD)

3. 33'F'Category units as identified by Govt. of Delhi (identified by an Expert Group)

4. Prohibited/Negative list of Industries as per MPD 2021

DPCC shall take action on basis of the complaints received by it against the specific units. Based on preliminary scrutiny of the complaints against specific units, inspections shall be carried out and if the industry / unit falls under any of the above mentioned four categories, DPCC shall take action for immediate closure of the unit by directing the concerned Deputy Commissioners (Revenue District) for its effective closure, as per the Hon'ble Supreme Court's judgment(s)/Master Plan of Delhi. Copy of such letters issued in non-conforming/residential areas shall also be forwarded to MCD, DDA with a copy to Commissioner of Industries.

Apart from aforementioned categories of industries / units the remaining complaints in non-conforming / residential areas of Delhi and the general complaints relating to entire non conforming / residential areas, shall continue to be forwarded to Municipal Corporation of Delhi(Factory Licensing Department), Delhi Development Authority and other concerned agencies, for taking necessary closure action, as per the Hon'ble Supreme Court's judgment Dated 07.05.2004 [WP(C) No. 4677 of 1985, M. C. Mehta Vs. UOI & Ors] regarding closure / shifting of the unauthorized / illegal / non conforming industries in non conforming /resid ential areas of Delhi. Copy of such forwarding letters shall also be sent to the Commissioner of Industries (working as a nodal officer on behalf of the Supreme Court Monitoring Committee) for compilation of records in pursuance of the said judgement of the Hon'ble Supreme Court.

Action for closure of 'H' Category units as per Master Plan of Delhi 2001 and Prohibited/Negative list of Industries as per MPD 2021 in industrial areas/redevelopment clusters as identified in MPD 2021 will also be carried out on similar lines.
