Meeting of the BMW Committee No. 3, constituted for deciding application for authorization under BMW Rules and Consent under Air / Water Acts was held on 20.03.2008, in the Chamber of SEE (BMW) and 125 cases of the Health Care Establishments having upto 9 Beds were placed before the Committee and decisions taken are given below ;

- (i) It was discussed that the units covered under BMW Committee No. 1 & 2 are being asked to submit Application for Consent to Establish under the Air & Water Acts. It was found that in all the 125 cases placed before the Committee, Health Care Establishments (HCEs) have not applied for Consent to Establish under the Air & Water Acts. The Committee decided that Letter be issued, seeking application for Consent to Establish under Air & Water Acts within one month in all the 125 cases. In case the HCEs do not have the DG Sets they may be advised to submit an Affidavit in this regard.
- (ii) HCEs listed at Sl. No. 92, 94, 95, 110 and 125 may be asked to provide a copy of the valid agreement with the Operator of Common Bio- Medical Waste Treatment Facility.
