Meeting of the BMW Committee No. 3, constituted for deciding application for authorization under BMW Rules and Consent under Air / Water Acts was held on 31.03.2008, in the Chamber of SEE (BMW) and 162 cases of the Health Care Establishments having upto 9 Beds were placed before the Committee and decisions taken are given below ;

I.The Committee perused the decisions taken by the Chairman, DPCC, on the issues raised by the Committee in its meeting held 28.11.07. Following decision was taken by the Chairman, DPCC , w.r.t. issue of Balance Fee ;

“DPCC should have uniform practice for all the Committees / Cells and the practice of issuance of authorization and Consent from the date of expiry of previous Authorization/ Consent , as is being followed by Consent Management Cell, may be followed”.

Balance fee asked earlier prior to the meeting of the Committee No. 3 , on 28.11.07, shall be sought from the HCUs if not submitted. Enquiry Counter of DPCC, should also be informed regarding the said decision taken by the Chairman, DPCC.

II.Regarding decision taken earlier by the Committee in its meeting on 28.11.07 (pl refer point no 1 of the minutes) for issuance of reminder letter to the HCUs which have neither submitted application for Consent to Operate under Air Act nor submitted an affidavit for not having DG Set , it was decided that reminder letter be issued within 15 days.

III. The units which have informed regarding not having DG Set and also submitted an affidavit in this regard(pl refer point no 1 of the minutes of meeting on 28.11.08) 10 % cases are to be inspected as per the decision taken by the Committee & approval of Chairman, DPCC. The Committee decided that inspection may be carried out in following cases (i) Gupta Maternity Home, C – 490 , Vikas Puri, Delhi.

IV. Regarding pending inspections the Committee did not appreciate the delay in inspections .The Committee agreed to the request of BMW Officers for completing the pending inspections (25 inspections as decided by the Committee in its earlier meetings)by next meeting.

V. Regarding 9 HCUs which have reported closure of their units / Letters demanding balance fee have been returned back (pl refer point no 4 of the minutes of the meeting on 28.11.07) , as decided earlier , inspection of these units be carried out.

VI.Action Taken Report on the last meeting of the Committee on 20.03.08 be placed before the Committee in its next meeting.

VII. Decisions taken by the Committee in 162 Cases of HCUs are given at **Annexure I.** The Committee decided to ask for balance fee for the late submission of application, as per CMC policy. In many cases the position w.r.t agreement with Private Operator of Common Bio – Medical Waste Treatment Facility was not clear . It was decided to confirm the position before issuing a query letter.
