OFFICE ORDER

Hon'ble National Green Tribunal in Application No. 516 of 2016 entitled as "Mahendra Pandey Vs Union of India & Ors., with respect to Chickungunya and other allied disease in Delhi, vide its order dated 21.09.2016 has constituted a Principal Committee and Zonal committee (copy of the order enclosed).
