PUBLIC NOTICE

Public Hearing for Environmental Clearance to the construction of Proposed 1000 MW Gas Based Combined Cycle Power Project at Bawana, Delhi (Pragati-III).

Whereas, M/s Pragati Power Corporation Ltd. (PPCL) has applied for seeking consent under Air & Water Acts for the proposal of the construction of Proposed 1000 MW Gas Based Combined Cycle Power Project at Bawana, Delhi (Pragati-III).

And whereas, notification no. S.O. 1533 dated 14th September, 2006 provides that projects, specified in schedule appended to the notification, shall not be undertaken unless it has been accorded environmental clearance by the Ministry of Environment & Forests, Govt. of India.

And whereas, above project is covered under the category of projects "Thermal Power Plants, mentioned at Sr. No. 1 (d) of Schedule- List of Projects or Activities requiring prior environmental clearance." requiring the environmental clearance from Ministry of Environment & Forest

And whereas, schedule appended for the notification aforesaid provides for public hearing by the Pollution Control Board / Committee inviting suggestions/ views/ comments/ objections from the affected persons before Ministry of Environment & Forest, Govt. of India takes up the case for the environmental clearance.

Now, therefore, Delhi Pollution Control Committee invites suggestions/ views/ comments/ objections from the persons likely to be affected by the grant of environmental clearance which shall include local authorities, association of person likely to be affected by the project and environmental groups within 30 days of publication of the notice. One hard and one soft copy of EIA report / executive summary of proposed project can be inspected by interested persons in the following places on all working days from 10.00 AM to 5.00 PM for submitting written suggestions to the DPCC:-
